Nothing on the Website constitutes investment, financial, trading, or legal advice.

1.3. User Responsibility

All trading decisions are solely your responsibility.

You acknowledge that you should obtain independent financial advice from a qualified professional

before making any investment or trading decisions.

1.4. Past Performance

Historical performance does not guarantee or predict future results.

2. Acceptance of Terms

By creating an account, accessing the Website, or using any portion of the Service, you confirm

that:

- You are at least 18 years old or of legal majority in your jurisdiction.
- You have read, understood, and agree to comply with these Terms.

3. Account Registration and Security

3.1. Accurate Information

You agree to provide accurate, complete, and current information upon registration.

Providing false or outdated information constitutes a breach of these Terms and may lead

to immediate account termination.

3.2. Security of Credentials

You are responsible for maintaining the confidentiality of your password and any other login

credentials.

You agree not to share your account or password with any third party.

3.3. Unauthorized Access

You must notify the Company immediately if you become aware of:

- Unauthorized access to your account
- Any security breach affecting the Service

The Company is not liable for losses resulting from your failure to safeguard your account.

4. Intellectual Property Rights

4.1. Ownership

The Service and all original content, features, and functionality (excluding User Content) are the

exclusive property of Forex City Pro and its licensors.

The Service is protected by copyright, trademark, and other applicable laws of **Saint Lucia**.

4.2. License to Use

You are granted a limited, non-exclusive, non-transferable, revocable license to access and use

the Service for personal, non-commercial purposes only. You may not:

least 30 days before the revised Terms take effect. Continued use of the Service after the effective

date constitutes acceptance of the updated Terms.
